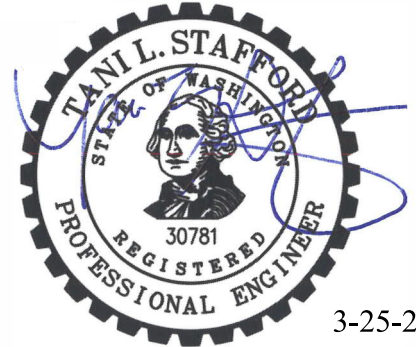

TO PROSPECTIVE BIDDERS:

The attention of all prospective bidders on the above project is directed to the following additions and modifications to the Contract Provisions and Contract Plans.

I. ADDITIONS, MODIFICATIONS, AND/OR DELETIONS TO THE CALL FOR BIDS

ITEM 1:

Page CB-1 Call for Bids

REVISE the first paragraph (1st Revision Addendum 1) as shown below (added text is italicized, deleted text is shown as strike out):

“Sealed Proposals will be received, via mail only, by the undersigned at the City of Buckley, 933 Main Street, Buckley Washington 98321, ~~up to 1:00 p.m.; local time, by the last USPS, FedEx or UPS delivery time on Wednesday, April 1, 2020, Thursday April 2, 2020,~~ for furnishing the necessary labor, materials, equipment, tools and guarantees thereof to construct the Cedar Street Improvements. ~~Additionally, sealed proposals will be received at the front counter at the City of Buckley, 933 Main Street, Buckley Washington 98321, from 10:00 a.m. and 1:00 p.m., on the bid opening date. Physical drop off of bids, in person, is not allowed.”~~

ITEM 2:

Page CB-1 Call for Bids

DELETE the fourth paragraph and **REPLACE** with the following:

The Proposals will be publicly opened and read aloud on Thursday, April 2, 2020 at 1:00 p.m. (local time). Bidders may attend the bid opening via conference call at (206)284-0860, ask the receptionist for conference call line 480. At the prompts enter 480# to be connected to the conference call. Proposals are to be submitted only on the form provided with the Bid Documents. All Proposals must be accompanied by a certified check, postal money order, cashiers check, or Proposal bond payable to the “City of Buckley” and in an amount of not less than five percent (5%) of the total Proposal amount.”

II. ADDITIONS, MODIFICATIONS, AND/OR DELETIONS TO THE PROPOSAL

ITEM 1:

Page P-4, Proposal

On Bid Item 108, DI Storm Sewer Pipe, 12 In. Diam (Incl. Bedding), **DELETE** the bid item name and quantity “DI Storm Sewer Pipe, 12 In. Diam (Incl. Bedding) 500 LF” and **REPLACE** with the following:

“DI Storm Sewer Pipe, 8 In. and 12 In. Diam (Incl. Bedding) 710 LF”

ITEM 2:

Page P-4, Proposal

On Bid Item 109, CPEP Storm Sewer Pipe, 12 In. Diam (Incl. Bedding), **DELETE** the quantity “430 LF” and **REPLACE** it with the following:

“340 LF”

ITEM 3:

Page P-10, Proposal

On Bid Item 420, Plastic Crosswalk Line, **DELETE** the quantity “80 SF” and **REPLACE** with the following:

“410 SF”
