TO PROSPECTIVE BIDDERS:

The attention of all prospective bidders on the above project is directed to the following additions and modifications to the Contract Provisions and Contract Plans.

I. ADDITIONS, MODIFICATIONS, AND/OR DELETIONS TO THE CALL FOR BIDS

ITEM 1:

Page CB-1 Call for Bids

DELETE the first paragraph in its entirety and **REPLACE** with the following:

“Sealed Proposals will be received, via mail only, by the undersigned at the City of Buckley, 933 Main Street, Buckley Washington 98321,-by the last USPS, FedEx or UPS delivery time on Wednesday, April 1, 2020, for furnishing the necessary labor, materials, equipment, tools and guarantees thereof to construct the Cedar Street Improvements. Physical drop off of bids, in person, is allowed at the City of Buckley Public Works Shop located at 240 River Avenue, Buckley, Washington 98321, between 8:00 a.m. and 1:00 p.m. (local time) on the bid opening date.”

ITEM 2:

Page CB-1 Call for Bids

REVISE the fourth paragraph (Addendum 2) as shown below (added text is italicized, deleted text is shown as strike out):

The Proposals will be publicly opened and read aloud on Thursday, April 2, 2020 at ~~4:00~~ *1:15* p.m. (local time). Bidders may attend the bid opening via conference call at (206)284-0860, ask the receptionist for conference call line 480. At the prompts enter 480# to be connected to the conference call. Proposals are to be submitted only on the form provided with the Bid Documents. All Proposals must be accompanied by a certified check, postal money order, cashiers check, or Proposal bond payable to the “City of Buckley” and in an amount of not less than five percent (5%) of the total Proposal amount.”

II. ADDITIONS, MODIFICATIONS, AND/OR DELETIONS TO THE SPECIAL PROVISIONS

ITEM 1:

Page 1-54, Special Provision 1-07.23(1) Construction Under Traffic, page 1-45

On line 12, **DELETE** the phrase “Cedar Street (East Mason to Main Street) and the” in its entirety.
